# Fair Banding Assessment Supplementary Guidance <br> Trinity Academy Bradford (TAB) - 180 places 

## This information relates to entry into Year 7 in 2025-26 Final deadline for completing and submitting the Fair Banding Registration Form is Monday 23 September 2024

For pupils interested in applying for a place at TAB, parents/carers will need to register their child to sit a non-verbal reasoning assessment (a Fair Banding Assessment) no later than Monday 23 September 2024.

Note: Applicants can only sit the Fair Banding Assessment once.
Sitting the assessment - Trinity Academy Bradford works collaboratively with many local primary schools to arrange for their Y 6 children to sit the assessment in the familiar surroundings of their own classroom, where children feel more comfortable. Please contact your local primary school to establish if they are working with us. If your child attends a school where the assessment is not administered in-house, you will be informed via email and invited to sit the assessment at Trinity on Saturday 12 October 2024.

## Applicants who sit the Fair Banding Assessment will be considered for admission first.

Any applicants who choose not to sit the Fair Banding Assessment will be 'non-banded' and will be ranked in order of priority (after all the banded applicants), with the level of priority then determined with reference to the oversubscription criteria (see Trinity Academy Bradford's Admissions Policy).

The results of this assessment will be used for the purpose of assisting the academy in placing applicants into one of four bands (1-4) dependent on their Fair Banding Assessment score. The boundaries of each band reflect national benchmarks. We will admit the required number from each band based on the spread of ability of those applying.

The assessment is externally set by a well-established educational assessment agency and the papers are collected and marked. The academy is then provided with a list of each child's assessment mark, similar to an IQ score, with 100 being the average. The marks are divided into four bands, and we are instructed how many children to take from each band e.g. if $40 \%$ of those applying are identified in band 2 , then $40 \%$ of our intake has to be from this band. This ensures that the places offered reflect the ability range of our applicants.

The assessment is not a traditional entrance exam which children either pass or fail; it is done to ensure that our intake exactly matches the ability profile of the children applying. For children with SEND - At the request of a primary school or parent/carer, additional steps will be taken to ensure reasonable adjustments are made to the assessment or an alternative (more appropriate) assessment is sought.

## How to register to sit the Fair Banding Assessment:

The parents of pupils interested in applying to TAB need to complete a Fair Banding Assessment Registration Form - Please follow the link (To be confirmed)
A hard copy of the form can also be obtained directly from the academy.
Registration forms are available for completion from Tuesday 1 July 2024 to the deadline of Monday 23 September 2024.

Parents/carers of children who sit the Fair Banding Assessment in October will be informed of the band their child has been allocated to, prior to the national deadline for secondary school applications.

The admission assessment will consist of a nationally validated assessment, supplied by a recognised body such as GL Assessment. The assessment is a predictor of future performance and as such does not rely upon material that will be covered in the primary school curriculum. The results from the assessment are standardised and aged-weighted. Exemplar material, including examples of assessment questions, is available from our academy website or can be obtained directly from the academy.

## Important information for all parents/carers:

Parents/carers of Y6 primary school children (regardless of which school they wish to attend) must also complete Bradford Local Authority's Common Application Form (CAF) for Admissions.
